GENERAL INSTRUCTIONS TO CANDIDATES FOR ADMISSION IN PG PROGRAMMES FOR THE AY 2026-27

1. The Merit-list of provisionally selected candidates for the following Post-graduate programme is uploaded on the University website <https://www.cug.ac.in>. **All candidates are advised to visit the University website regularly for admission related information and updates.**

2. Admission Procedure:

- **Merit List and Fee Payment:** Provisionally selected candidates are hereby informed to pay their Admission fee to confirm the admission in respective programme within the stipulated time [As mentioned on the respective merit-list(s)].
- **Provisional Admission:** Admission to the Central University of Gujarat shall be subject to the condition that an applicant fulfilling all the eligibility criteria as mentioned on the University website at the time of the admission. It is the applicant's responsibility to ensure fulfilment of the eligibility criteria for a respective programme. Admission offered at the first instance by the University is considered as "Provisional Admission".
- **Eligibility and Qualifying Examination:**

A candidate appearing for admissions at CUG through CUET-PG 2026 must have appeared in the final examination of the qualifying degree and declared "PASSED" and should possess the minimum eligibility as per the eligibility criteria of the respective programme as mentioned.

Those candidates whose result of qualifying examination is not declared at the time of admission; they will be "Provisionally Admitted" for their respective programme at CUG. If such a candidate fails to secure the required minimum eligibility for admission as per eligibility criteria of respective programme and/or "FAIL" at the qualifying examination, as the case may be, their admission would be liable to be cancelled without assigning any reason(s) thereof whatsoever.

3. **Verification of Documents:** All candidates are required to produce all necessary "Original documents" establishing their eligibility at the time of document verification schedule as mentioned herein under along with the "Admission Fee Receipt" generated through SAMARTH eGov Portal. The schedule for document verification will be communicated through the University website in due course of time.

4. **Documents Submission:**

- **Migration/Transfer Certificate:** All the admitted candidates shall have to submit Migration/Transfer Certificate from their respective previous University/College/School positively on or before **31st August 2026**.
- A candidate meeting the minimum eligibility requirement is required to submit the relevant document of the qualifying examination to the Office of Controller of Examinations at the time of Document Verification, failing which the admission will be liable to be cancelled without assigning any reason(s) thereof whatsoever.
- During admission, if a candidate is not able to provide some of the necessary documents/certificates, the admission shall be considered "Provisional Admission". The last date of submission of any of the pending documents/certificates is **31st August 2026** failing which the admission shall be liable to be cancelled without assigning any reason(s) thereof whatsoever.

5. **Payment of Admission Fee:**

- The selected candidates shall be required to pay the requisite Admission fee within the stipulated time as mentioned on the respective merit-list of the concerned programme in which admission is offered. In case any candidate fails to pay the admission fee within the stipulated period, the offered admission shall stand withdrawn and the other candidate in the order of the merit-list will be offered the admission.

6. **Cancellation & Refund:**

- Any candidate who has been granted admission in any merit-list and if such a candidate wishes to cancel the admission, the process of cancellation must be carried out through the SAMARTH Portal Login of the concerned candidate. Cancellation of admission via email/tele-communication/any other mode of communication (Except through SAMARTH Portal Login) shall not be entertained into by the University. The refund of the Admission fee as per the UGC Guidelines as amended from time-to-time will be initiated after completion of the admission process (Admission cancellation is mandatory through SAMARTH Portal Login).

7. Important Notices

- **Academic Calendar 2026-27:** Academic calendar will be uploaded on University website (<https://www.cug.ac.in>)

The new session will be commencing from 22nd June 2026. The detail time table for the 1st year of respective programme will be shared by respective department /school/centre as the case may be. Accordingly, all the candidates who have been offered the admission are advised to consult their respective School/Department for information about the Timetable and commencement of classes.

- **Attendance:** 75% attendance is mandatory, failing which the concerned student shall not be allowed to appear at the University examination (Meeting of Deans 07.08.2023).
- **Ragging:** As per the directives of Hon'ble Supreme Court of India, ragging of any kind is prohibited within and outside the premises of the University. Any candidate found guilty of being involved in ragging and/or abetting ragging, is liable to be punished appropriately as per rules of the University/UGC guidelines as amended from time-to-time.
- **Fake/Forged Documents:** If any certificate(s) is/are found fake / fabricated / falsified / forged at any point of time during or after the course of study, the admission of such a candidate is liable to be cancelled or if degree has been awarded to such a candidate, the awarded degree will be declared "Null and Void".
- **University Rights:** The University reserves the right to cancel the application and admission of any candidate for wrongful submission of facts pertaining to qualification, reservation and/or any other matters without assigning any reason(s) whatsoever thereof. If any candidate is found involved and/or prosecuted under any criminal proceedings and/or any disciplinary proceedings at any stage of the students-ship, the admission shall be liable for cancellation without assigning any reason(s) whatsoever thereof.
- **It will be the responsibility of the candidate to visit the University website regularly for any updates about the admission process.**

8. Hostel Facility:

- **Please be informed that hostel facilities are limited, and hostel rooms will be allotted strictly on a merit basis.**
