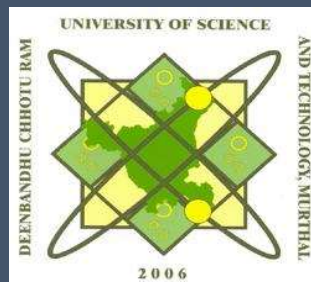

CHAPTER – 2

CRITERIA FOR RESERVED SEATS ECONOMICALLY WEAKER SECTION (EWS)

The persons belonging to EWS who are not covered under the existing scheme of reservation for OSC, DSC, BC-A and BC-B shall get 10% reservation in admission to govt. aided /govt. educational institutes in the state of Haryana (information received from Director Technical Education, Sector-4 Panchkula vide Memo No. 220 dated 8.5.2019 Govt. notification No. 22/12/2019-1GS-III dated 13th March, 2019)

CRITERIA OF INCOME AND ASSETS:

1. Persons who are not covered under the existing scheme of reservation for OSC/DSC/BC-A and BC-B whose family has gross annual income below Rs. 800000/- (Rs. Eight Lakhs Only) are to be identified as EWS for benefit for reservation (as per Appendix-I). Income shall also include from all sources i.e. salary, agriculture, business, profession etc for the financial year prior to be year of application.
2. All persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS irrespective of the family income.
 - Five acres of agricultural land and above
 - Residential flats of 1000 sq.ft. and above
 - Residential plot of 100 sq. yards and above on notified municipalities
 - Residential plot of 200 sq. yards and above in areas other than the notified municipalities
 - Total immovable assets owned are valued at Rs. One Crore or more
3. The property held by a “family” in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
4. The term ‘family’ for this purpose will include the persons who applies for benefits of reservation, his/her parents, spouse as well children and sub links below the age of 18 years
5. The competent authority of EWS income certificate shall be Tehsildar of the area where the applicant normally resides/ same as prescribed for issue of resident/income certificate as specified in instruction No. 22/28/2003- 3GS-3 dated 30.1.2004
6. The gross annual income of parents shown in the certificate should be of financial year 2025-26 and certificate should be issued on or after 01.04.2026.
7. Prescribed format for EWS income and assets certificate is provided in at Annexure XI.

SPORTS QUOTA (SPQ)

SPORTS WEIGHTAGE IN ADMISSIONS (subject to the approval of Academic Council)

Supernumerary seats have been created in all courses of University (Except courses run under PCI, AICTE and NCTE), whose admissions are made at university level. The details of number of seats for outstanding sports persons in different courses are as under:

- a) 01 No. seat (where number of sanctioned seats is less than or equal to 30)
- b) 02 Nos. seats (where number of sanctioned seats is more than 30)

The Outstanding Sports Person means a person who has represented in the tournaments and full filling other conditions as prescribed in the University Prospectus.

In case of tie in the sports achievement level/Merit as per point (v) then the merit of Entrance Test considered for respective course will be considered for deciding the merit. In case of admissions made on merit of qualifying exam, than merit of qualifying exam will be considered. If still there is tie, then the age will be considered for the merit (Higher in the age will be considered for the merit).

Registered applicants must report to Director of Sports with all prescribed documents on the notified dates. The sports committee will conduct all tests and will prepare a merit list for various programmes.

DOCUMENT REQUIRED FOR ADMISSION UNDER SPORTS CATEGORY:

The following documents are required for admission under sports category:

1. Self-attested photocopies of sports certificates with photograph duly attested by the respective issuing authority or Head of the Institution of last attended along with their originals.
2. Undertaking of sports achievements (Annexure XII (1)) and attendance in sports grounds (Annexure XII (2)) both in original.
3. Roster form/list of players/ competitors of the concerned tournament duly attested by the respective issuing authority or Head of Institution last attended.

LIST OF SPORTS DISCIPLINES ELIGIBLE FOR ADMISSION UNDER CATEGORY OF SPORTS

Sports disciplines to be considered for admission under reserved category of sports will be based on the following conditions:

1. The sports disciplines should also be part of proceeding Olympic / Asian Games / Commonwealth Games immediately preceding the year of admission.
2. Apart from the above the following two sports disciplines are included based on popularity / indigenous.
 - a) Chess
 - b) Cricket

THE FOLLOWING GUIDELINES WILL BE FOLLOWED

- a) One supernumerary seat has been created by the University in UGC courses/programmes (Except AICTE programmes) being run in the University teaching departments for a single

child of her parents or one amongst the only two girl children with no male child. This supernumerary seat will be available to only one of the two girl children of her parents.

- e) The supernumerary seat should be offered to only single girl child of Haryana state provided she is otherwise eligible from all angles.
- f) If there is more than one claimant to the seat under this category, the admissions will be made as per the merit list of entrance test.

KASHMIRI MIGRANT (KM)

The candidate who fulfils any one or more conditions of the following criteria be considered for Bonafide resident of the Village Murthal for giving such benefit: -

- (a) The candidates, who have passed the qualifying examination from school/college in the purview of the Village Panchayat of that Village.
- (b) Children/wards (if parents not living) dependents of persons who after retirement have permanently settled in that village and are residing for more than three years from the date of issue of such certificate.
- (c) Children/wards (if parents not living) dependents of pensioner of Haryana Government irrespective of the fact that the original home of the retiree is in that village and after retirement he has settled in that village or outside.
- (d) Children/ward (if parents are not living) dependents of persons, who have permanent home in that village and include persons who have been residing in that village for a period of not less than 15 years or who have permanent home in that village but on account of their occupation they are living outside that village.
- (e) The wives of such persons who are Bonafide residents of that village irrespective of the fact that they had belonged to any place before marriage.

ENTRANCE TEST:

1. Entrance tests for making admissions to various PG /BCA/ Integrated Programmes of the university will be held at the University Campus as per schedule of events.
2. Candidates with valid GATE score need not to appear in the entrance test for admission to M. Tech.
3. All eligible candidates including those appearing in final year of qualifying degree in academic session 2025-26 can appear in the entrance test (as applicable). Mere taking of the entrance test shall not entitle a candidate for admission. However, the eligibility of candidates shall be determined at the time of counselling and admission.
4. Entrance test for admission to all academic programs except Master in Hospital Administration (MHA and Certificate courses in German/French) shall have 120 Multiple Choice Questions with only one correct choice and time allotted to answer the questions shall be 120 minutes. There shall be no negative marking; each question will have equal weightage.

Quantum Mechanics: Black-body radiation, Plank's radiation law, photoelectric effect, heat capacity of solids, Compton effect, Schrodinger Equation, wave function and its significance, postulates of quantum mechanics, quantum mechanical operators, commutation relations, Role of operators in quantum mechanics, Particle in one dimensional box.

Molecular Spectroscopy: Electromagnetic radiation, regions of spectrum, basic features of spectroscopy, statement of Born-oppenheimer approximation, Degrees of freedom. Elementary idea of Rotational (rigid rotor), Vibrational (harmonic & anharmonic oscillator) and Raman Spectra of simple diatomic molecules.

Inorganic Chemistry

Atomic Structure: Fundamental particles. Bohr's theory of hydrogen atom, Wave-particle duality, Uncertainty principles, Schrodinger's wave equation, Quantum numbers, shapes of orbitals, Hund's rule and Pauli's exclusion principle.

Periodic Properties: Periodic classification of elements and periodicity in properties, Atomic and ionic radii, ionization energy, electron affinity and electronegativity – definition, methods of determination or evaluation, trends in periodic table (in s & p block elements).

Chemical Bonding and Shapes of Compounds: Types of bonding, Valence Bond Theory and Molecular Orbital theory of diatomic molecules, VSEPR theory and shapes of molecules, hybridization, dipole moment.

Solid State: Ionic structures (NaCl, CsCl, ZnS (Zinc Blende), CaF₂, diamond, graphite etc.) radius ratio rule, lattice defects, lattice energy and Born-Haber cycle.

Hard and Soft Acids and Bases: Classification of acids and bases as hard and soft. Pearson's HSAB concept, acid-base strength and hardness and softness, Symbiosis, Liquid NH₃ as non-aqueous solvent.

Main Group Elements (s and p blocks): Chemistry with emphasis on group relationship and gradation in properties, structure of electron deficient compounds of main group elements and application of main group elements (s & p-block including noble gases).

Chemistry of d & f-block elements: Characteristics of 3d elements, oxide, hydroxide and salts of first row transition metals, General properties of lanthanides and actinides.

Coordination Chemistry: Nomenclature and stereochemistry, VB and Crystal Field theoretical approaches for structure & bonding, colour (electronic spectra) and magnetic properties of transition metal complexes. Thermodynamic and Kinetic Aspects of Metal Complexes

Organometallic Chemistry: Definition, nomenclature and classification of organometallic compounds. Preparation, properties, bonding and applications of alkyls and aryls of Li, Al, Hg, Sn and Ti, metal- ethylenic complexes and homogeneous hydrogenation, mononuclear carbonyls and

the nature of bonding in metal carbonyls. Organomagnesium compounds: the Grignard reagents - formation, structure and chemical reactions. Organozinc compounds: formation and chemical reactions.

Bioinorganic Chemistry: Essential and trace elements in biological processes, metallo-porphyrins with special reference to haemoglobin and myoglobin. Biological role of alkali and alkaline earth metal ions with special reference to Ca^{2+} . Nitrogen Fixation.

Qualitative and quantitative Analysis: Basic theory of volumetric titrations (acid-base, redox, complexometric, precipitation), Salt analysis (detection of acid and basic radicals)

Organic Chemistry

Basic Concepts in Organic Chemistry and Stereochemistry: Isomerism and nomenclature, electronic (resonance and inductive) effects. Optical isomerism in compounds containing one and two asymmetric centers, designation of absolute configuration, conformations of cyclohexanes.

Organic Reaction Mechanism and Synthetic Applications: Methods of preparation and reactions of alkanes, alkenes, alkynes, arenes and their simple functional derivatives, alcohols, ethers, phenols, aldehydes, ketones, carboxylic acid and carboxylic acid derivatives. Mechanism and synthetic applications of electrophilic aromatic substitution. Stereochemistry and mechanism of aliphatic nucleophilic substitution and elimination reactions. Diels – Alder reactions, Wittig Reactions, Mechanism of aldol condensation, Claisen condensation, esterification and ester hydrolysis, Cannizzaro reaction, benzoin condensation. Perkin reaction, Claisen rearrangement, Beckmann rearrangement and Wagner – Meerwein rearrangement.

Introduction to the following classes of compounds – Carbohydrates, Amino Acids, Peptides, Proteins and Nucleic Acids, Fats, Oils and Detergents

Heterocyclic Chemistry : Furans, thiophenes, pyrrols and pyridines.

Qualitative Organic Analysis : Functional group interconversions, structural problems using chemical reactions, identification of functional groups by chemical tests. Spectroscopy-IR, NMR, UV.

M.Sc. (Mathematics)

Algebra: Elementary operations on Matrices, Inverse of a matrix, Rank of a Matrix, Eigen values and vectors, Characteristic Equation of a matrix, Cayley Hamilton Theorem, Test for consistency of a system of linear equations. Relation between the roots and coefficients of general polynomial equation in one variable, Transformation of equations, Descartes's rule of signs. Mappings, Equivalence Relations and Partitions, Congruence modulo n . Groups, Cyclic groups, Lagrange's Theorem, Normal subgroups, Quotient groups, Fundamental Theorem of Homomorphism, Permutation groups, Even and Odd Permutations, Alternating groups, Cayley Theorem. Class Equation for a finite group, Sylow groups, Structure Theorems for finite abelian groups, Ring Homomorphism, Ideals and Quotient rings, Polynomial rings, Eisenstein Criterion of Irreducibility, Vector space, Linear Independence, Basis, Dimension, Linear Transformation, Rank and Nullity theorem, Diagonalization of Matrices, Bilinear, Quadratic and Hermitian forms, Inner Product spaces, Orthogonal basis, Gram-Schmidt Process, Inequalities.

Calculus: Successive Differentiation, Leibnitz Theorem, Taylor's theorem, Asymptotes, Curvature, Sequence and Series, Tests for Convergence of Series, Alternating Series, Absolute and conditional convergence, Continuity and differentiability, Uniform continuity, Mean value theorems, Partial differentiation, Change of variables, Euler's theorem on homogeneous functions, Taylor's theorem for two variables, Jacobians, Maxima, Minima of functions of two variables, Lagrange's multiplier method, Indeterminate forms, Beta and Gamma functions, Double and Triple integrals, Dirichlet's integral, Change of order of integration in double integrals.

Analysis: Riemann integral, Mean value theorems, Improper integrals and their convergence, Series of arbitrary terms and their convergence, Abel's, Dirichlet's tests, Double series, Fourier Series, Schwartz and Young's Theorem, Analyticity and continuity of functions, C-R equations, Harmonic functions, Mobius transformation, Fixed points, Cross ratio, Inverse points, critical mappings.

Metric Space: Cauchy Sequences, Completeness, Cantor's intersection theorem, Completely ordered fields, Baire Category Theorem, Separable, second countable and first countable spaces, Compactness, Connectedness.

Differential Equations: Ordinary differential equations and their Types, Formulation and solution by various methods including series solutions, Bessel, Legendre and Hypergeometric functions, Laplace and Fourier Transforms and their properties, convolution, Solution of differential equations using transforms, Partial differential equations and their solutions, Charpit method, Classification of p.d.e.'s of second order, Homogeneous and non-homogeneous p.d.e.'s

Differential Geometry: General equation of second degree, Conics, Conoids, Generating lines, Reduction of second degree equations, Sphere, Cone, Cylinder, Curves with torsion, Serret-Frenet formulae.

Mechanics: Analytical conditions of equilibrium of coplanar forces, forces in three dimension, Null lines and planes, Stable and unstable equilibrium, Velocities and accelerations, S.H.M., Motion on smooth and rough plane curves, Kepler's law of motion, Motion of a particle in three dimension.

Numerical Analysis: Interpolation, Forward, Backward and Central Difference formulae, Numerical differentiation and integration, Methods of solving system of linear equations, Methods of solving algebraic and transcendental equations, Solutions of differential equations using numerical methods.

Programming in C: Programmer's model of a computer, Algorithms, Flow Charts, Data types, Arithmetic and input/output instructions, Decision control structures, Operators in C, loop, Case control structures, functions, Recursions, Preprocessors, Structures, File formatting.

Vector Analysis: Scalar and vector product of three vectors, vector differentiation, integration, Gradient, Divergence and Curl, Gauss, Green, Stokes Theorem

Trigonometry: DeMoivre's theorem and its applications, Gregory series, Summation of series, Expansion of trigonometric functions.

M.Sc. (Physics)

Mechanics and General Properties of Matter: Newton's Laws of Motion and applications, Velocity and acceleration in Cartesian, Polar and Cylindrical Coordinate Systems, Uniformly rotating frame, Centrifugal and Coriolis Forces, Motion under a central force, Kepler's Laws, Gravitational Law and field, Conservative and Non-conservative forces, System of particles, Centre of Mass, Equation of motion of the CM, Conservation of linear and angular momentum, Conservation of energy, Variable Mass Systems, Elastic and inelastic collisions, Rigid Body Motion, Fixed axis rotations, Rotation and Translation, Moments of Inertia and products of Inertia, Principal moments and axes, Elasticity, Hooke's Law and elastic constants of isotropic solid, Stress energy, Young Modules, Kinematics of Moving fluids, Equation of continuity, Euler's equation, Bernoulli's theorem, Viscous fluids, Surface Tension and surface energy, capillarity.

Oscillations, Waves and Optics: Differential equation for simple harmonic oscillator and its general solution, Superposition of two or more simple harmonic oscillators, Lissajous figures. Damped and forced oscillators, resonance. Wave equation, travelling and standing waves in one-dimension. Energy density and energy transmission in waves, Group velocity and phase velocity, Sound Waves in media, Doppler Effect, Fermat's Principle, General theory of image formation, Thick lens, thin lens and lens combinations. Interference of light, optical path retardation, Fresnel & Fraunhofer diffraction, Rayleigh criterion and resolving power, Diffraction gratings, Polarization: Linear, Circular and Elliptic polarization. Double refraction, Optical polarizer and analyser.

Electricity and Magnetism: Coulomb's Law, Gauss's Law. Electric field and potential. Electrostatic boundary conditions, Solution of Laplace's equation for simple cases. Conductors, capacitors, dielectrics, dielectric polarization, volume and surface charges, electrostatic energy. Mesh Analysis and Nodal analysis of circuit. Lorentz Force and motion of charges particles in electric and magnetic fields.

Kinetic Theory, Thermodynamics: Elements of Kinetic theory of gases, Velocity distribution and Equipartition of energy. Specific heat of Mono-, di- and tri-atomic gases. Ideal Gas, Van-der-Waals gas and equation of state. Mean free path. Laws of thermodynamics. Zeroth Law and concept of thermal equilibrium. First Law and its consequences. Isothermal and adiabatic processes. Reversible, irreversible and quasi-static processes. Second Law and entropy. Carnot cycle. Maxwell's thermodynamic relation and simple applications. Thermodynamic potentials and their applications. Phase transitions and Clausius-Clapeyron equation.

Modern Physics: Inertial frames and Galilean invariance. Postulates of special relativity. Lorentz transformations. Length contraction, time dilation. Relativistic velocity addition theorem, mass energy equivalence. Blackbody radiation, photoelectric effect, Compton Effect, Bohr's atomic model, X-rays, Wave Particle duality, Uncertainty principle, Schrodinger equation and its solution for one, two and three dimensional boxes. Reflection and transmission at a step potential, tunneling through a barrier. Pauli exclusion principle. Distinguishable and indistinguishable particles. Maxwell-Boltzmann, Fermi-Dirac and Bose-Einstein Statistics.

Solid State Physics: Crystal structure, Bravais lattices and basis, Miller indices. X-ray diffraction and Bragg's law, Einstein and Debye theory of specific heat. Free electron theory of metal. Fermi energy and density of states. Origin of energy bands. Concept of holes and effective mass. Elementary ideas about dia-, para- and ferromagnetism, Langevin's theory of paramagnetism, Curie's Law, B-H Curve, Hysteresis and energy loss. Superconductivity, Meissner effect, Type I & II Superconductors.

Electronics: Energy band theory, Intrinsic and extrinsic semiconductors. Fermi level. P-n junctions, diode, rectifier, L & π filter, Zener diode, LED, photodiode, Solarcell, Transistors, Transistors circuits in CB, CE, CC modes, load line analysis of transistors, Amplifier circuits with transistors, Oscillators circuits with transistors, Boolean algebra, De Morgan Theorem, OR, AND, NOR AND NAND gates.

Nuclear Physics: Nuclear composition (p-e and p-n hypotheses), Nuclear properties; Nuclear size, spin, parity, statistic, magnetic dipole moment, quadrupole moment (shape concept), Rutherford

Scattering, Alpha, Beta and Gamma decay and its theory, Linear accelerator, Tandem accelerator, Cyclotron and Betatron accelerators. Gas filled counters; Ionization chamber, proportional counter, G.M. Counter, Scintillation counter and semiconductor detector. Nuclear Reactors, General aspects of Reactor Design.

M.Sc (Biotechnology)

CHAPTER – 6

COUNSELLING AND ADMISSION

PG/BCA/INTEGRATED PROGRAMMES/CERTIFICATE COURSES

1. (a) The admission to PG programmes/Courses shall be open to the candidates having qualifying degree examination in any relevant discipline from any Indian University included in the approved list of Association of Indian Universities (AIU) or any foreign university recognized by AIU or any other central Govt. institution. Equivalent degree must be recognized from Govt. of India.

As per Govt. letter no. 42/158/2016-5GS1 dated 19.01.2018 issued by the chief secretary to Govt. of Haryana, the candidates who have obtained degrees/diploma through distance education mode after getting enrolled during 2001-2005 and also who were admitted after the academic session 2001-2005, their degrees/diploma are to be treated as cancelled. Accordingly, such degrees/diploma will not be considered for admission purpose.

MHRD, Govt. of India, through an order (vide OM no. 11-15/2011-AR (TS.II) dated 06.12.2012) withdrew the recognition granted to all certificates/ qualifications awarded by professional bodies / institutions in the field of technical education. The MHRD further stipulated that from 01.06.2013 onwards the courses for equivalence will cease (Refer AICTE Letter F. No.2-PC/AICTE/Gen. Dust, Edu. Policy/2018/439 Dated: 23.08.2018).

- (b) The admissions to PG/BCA/Integrated Programmes/Certificate Course shall be open to the candidates having qualifying examination in any relevant discipline from any Indian school/college recognized by centre or Haryana State Education Board (or equivalent).
2. The admission to PG/BCA/Integrated Programmes/Certificate Course shall be done by the concerned department of the university in respect of the courses run by it.
3. The admission to other PG Courses, in which there are no GATE score/CUET score (wherever applicable) are not available, shall be done on the merit of entrance examination conducted by university. Further, seats lying vacant will be filled on the basis of Academic Merit of qualifying examinations.
4. Seats shall be filled through following sequence (order of preference) for all counselling:

- a. First, the eligible candidates will be considered on merit of valid GATE score (Wherever applicable) for admission.
- b. After exhausting the criterion (a), eligible candidates will be considered for admission based on the merit list of the result of the entrance test conducted by the university.
- c. For PG Programmes: M.Sc. (Physics), M.Sc. (Chemistry), M.Sc. (Mathematics), M.Sc. (Environment Sciences), M.Sc. (Bio-Technology), M.A. (English).

&

For Integrated programmes: Integrated B.Sc. Physics (Hons./Hons. With Research) - M.Sc. Physics, Integrated B.Sc. Chemistry (Hons./Hons. With Research) - M.Sc. Chemistry, Integrated B.Sc. Mathematics (Hons./Hons. With Research) - M.Sc. Mathematics, Integrated B.Sc. Biotechnology (Hons./Hons. With Research) - M.Sc. Biotechnology, & Integrated B.A. English (Hons./Hons. With Research) - M.A. English.

After exhausting (criteria b), eligible candidates will be considered for admission based on merit list of CUET-2026 NTA Score (Normalized Score) of respective subject conducted by the NTA as mentioned in eligibility (chapter-1 of prospectus).

- d. After exhausting (criteria a&b&c as applicable), eligible candidates will be considered for admission on the basis of merit list of qualifying examination.
- e. Thereafter, if the seats still remain vacant, chance will be given to those who have cleared their all examinations upto pre final year/semester and appeared in final exam. Their relative merit shall be formed on the basis of their average % of marks up to pre final year/semester (% marks should be equal or more than given in Chapter-1 under eligibility conditions). Proof of qualifying final exam should be submitted (should fulfil the eligibility conditions as given in Chapter-1), otherwise admission shall stand cancelled automatically and all the dues/fees paid by them shall be forfeited.

In the case of tie in the merit list under any criterion, the following provisions shall apply:

- i. The eligible candidates with the result of the qualifying degree will be placed in higher merit as compared to candidates with all cleared examinations of pre final year/pre-final semester examination (Whatever applicable).
- ii. In the latter case, their relative merit shall be formed on the basis of their average % of marks up to pre final year/pre- final semester (% marks should be equal or more than given in Chapter-1 under eligibility conditions).

- iii. For Integrated B.Sc. Mathematics (Hons./Hons. With Research) - M.Sc. Mathematics
- In the case of tie in the merit list of criterion (b), eligible candidates with higher marks in Mathematics (Core) of qualifying examinations (i.e. 10+2) will be placed in higher merit.
- iv. After exhausting the above criteria, eligible candidates will be considered for admission on the basis of the age of the candidate (older shall be given the preference).
5. Admission in MHA (Masters in Hospital Administration) and Certificate Courses in German/French shall be made on the basis of Academic Merit of qualifying examinations.
6. If two or more candidates secure identical marks (score) in the entrance test/GATE/CUET Score (wherever applicable), their relative merit will be determined by the percentage of marks obtained by them in the qualifying examination. In case of percentage of marks secured in qualifying examination is also identical, the candidate older in age will be preferred.
7. Counselling and admission schedule shall be separately notified on the following link <https://dcrustmadm.samarth.edu.in>.
8. Only those candidates who present themselves personally on the specified date and time along with the originals of all the documents will be considered for admission.
9. Preference of the Course shall be got filled up by candidates at the time of Counselling and admission.

Fee will be paid online through candidate login Portal created at the time of registration.
(Refer University brochure for Fee structure for all the programmes)

Note: Candidates shall bring the following documents (as applicable) while reporting to counselling:

Note: There shall be sole responsibility of the candidate in case fee deposition is failed by this method because of internet failure or otherwise. If a candidate is eligible for admission to more than one M. Tech. Course, his/her valid GATE score shall be considered for the admission to such courses provided he/she has valid GATE score in one of the relevant disciplines of such courses.

10. The merit list will be prepared by the Chairperson of the concerned department on the basis of results of Entrance Test provided by the Controller of Examination.
11. All details/documents of the registered candidates of the concerned department will be available on samarth portal.
12. Chairperson of the Department will constitute an admission committee that will prepare the merit list (rank wise) of all the applicants.
13. Reserve category candidate(s) are also eligible in General Category (AIC / HOGC) provided that they scored marks in qualifying examination \geq the marks required for General Category i.e. 50% marks in qualifying examination (Refer Chapter 1 of Prospectus). Similarly valid GATE score should be \geq for General Category.
14. The counselling and admission in a programme will be held in the respective department as per the schedule mentioned in the prospectus. All the eligible candidates shall mark their attendance up to 10:00 a.m. on the scheduled date. Counselling will begin from 10:00 a.m. If any candidate reports after 10:00 a.m., he/she will mark his/her attendance mentioning time also and he/she will be offered available seat only at that time.
15. All original certificates will be verified at the time of counselling by the concerned committee of the department. For any reason, if a candidate is unable to upload/produce

original certificates at the time of admission, he/she will be allowed provisional admission on his/her application subject to verification of original certificates before next counselling time failing which his/her admission shall stand cancelled and fee forfeited. Such relaxation shall not be given in respect of category certificate (EWS, OSC/DSC, BC-A, BC-B, ESM, FF, PWD etc).

16. The provisional admission would be offered to the candidate in order of the rank of merit notified and displayed. If the candidate is not able to deposit the admission fee in the stipulated time schedule, then he/she will be considered "not interested" and accordingly such candidate will not be considered for subsequent counselling's. However, if such a candidate reports for counselling /shows his/her interest [in writing via e- mail/offline] in any subsequent counselling to the concerned Chairperson, before the display of merit list of any subsequent counselling (if scheduled) he/she will be considered in the order of merit for counselling against the vacant seats (if any).
17. If a candidate admitted during any Counselling, applies for cancellation of his/her admission, his/her admission will be cancelled by chairperson of the department on recommendation of the departmental admission committee.
18. Candidates claiming reservation under OSC/DSC and Backward Categories or any other reservation shall have to submit a certificate issued by the competent authority in the prescribed format (Annexure –IV(1/2)/V(1/2)).
19. The BC Candidates (Block 'A' & 'B') for benefit of reservation shall submit Backward Class Certificate Block A or B as given in Annexure –V(1/2). OBC certificate shall not be considered.

Notification No. 808-SW(1) dated 17 August, 2016 issued by Welfare of Scheduled Castes and Backward Classes Department, Haryana, the criteria for exclusion of creamy layer within the Backward Classes as per the Schedules appended to the Act, namely Scheduled I, II & III will be as under:

“The criteria for exclusion of persons within the Backward Class as creamy layer notified vide Notification No. 40/13/2024-1SW dated 16th July, 2024 by Haryana Government Social Justice, Empowerment, Welfare of Scheduled Castes and Backward Classes and Antyodaya (SEWA) Department will be applicable (for details refer to Appendix-IV)

Only candidates having the permanent disability of not less than 40% (being otherwise fit for admission to the course) will be considered for admission as physically handicapped. Disability certificate must be issued from Chief Medical Officer of the concerned District. However, the admission shall be provisional subject to verification by a Medical Board constituted by the University for the purpose. The decision of the Board shall be final.

20. If, the reserved seat(s) of Deprived Schedule Caste (DSC) remains vacant, these shall be filled up from Other Schedule Caste (OSC) such inter conversion between DSC and OSC shall be made in the third counselling.

If, the reserved seat(s) of Backward Class 'A' remains vacant, these shall be filled up from Backward Class 'B' such inter conversion between BC-A and BC-B shall be made in the third counselling.

21. The seats(s) reserved for Resident of Murthal (ROM), is/are considered as part of Haryana Open General Category (HOGC) i.e. such no. of seats are considered reserved out of HOGC category for Resident of Murthal.

The filling up of ROM seat(s) in AICTE PG programmes will be made on rotation basis among male & female candidates. If an eligible male candidate is not available then the seat will be filled up with female candidates & vice-versa.

Eligibility criteria for Resident of Murthal (ROM), mentioned in prospectus, shall be strictly followed.

If the candidates under reserved categories (Including ROM) in AICTE PG programmes are not available up to 3rd Counselling and the seats remain vacant, these shall be automatically considered converted. These seats along with other net resultant vacancies after the 3rd counselling shall be offered to General category candidates in the next subsequent counselling on all India Basis.

22. The vacant seats of reserve category will be converted into general category after 3rd Counselling onwards only when list of eligible candidates in a particular category is exhausted (Programme wise).

In the event of quota reserved for physically handicapped remain unutilized due to non-availability for suitable category of handicapped candidates, it may be offered to the Ex-Serviceman and their wards (1%) and the dependents of Freedom Fighters (1%) after second counselling by 10.30 a.m. on the day of 3rd Counselling. Thereafter, all the reserved seats, except Supernumerary seats (EWS, SPQ, UEQ, SGCQ, KM, ROM for UGC approved courses etc. will be converted into General Category (All India Basis).

Supernumerary seats are over and above sanctioned intake and cannot be converted into any other category.

23. Vacancy status, after each counselling shall be uploaded on the university website/admission portal for the information of the candidates and public in general. (Chairperson's responsibility)
24. A candidate, who furnishes particulars which are found to be false, or suppresses material information, will not be considered for admission and if he/she is admitted on such

information, notwithstanding the legal action under the law of the land, his/her admission shall be cancelled and all fees deposited by him/her shall be forfeited.

25. Before accepting the admission, the candidate must also ensure that he/she fulfils the minimum eligibility conditions for admission to the respective Programme.
26. All the admitted candidates will be governed by the Rules and Regulations and/ or relevant Ordinance (s) as laid down by the University.
27. In the event of any inconsistency in the rules or any clarification thereof, the matter shall be referred to Dean (Academic Affairs). Dean (academic Affairs)/ the Hon'ble Vice Chancellor of the University shall be competent for interpretation of the written rule (s) whose decision shall be final and binding.
28. Candidates appeared in final year / semester of qualifying examination in academic year 2025-26 can also apply. These candidates must have cleared all the examinations of pre-final year / pre-final semester examination. Proof of qualifying final exam should be submitted by 31st December 2026, otherwise admission shall stand cancelled automatically and all the dues/ fees paid by them shall be forfeited. (For all PG Programmes)

A candidate appearing for XII/ Higher Secondary or Equivalent qualifying examination in academic year 2025-26 can also apply. However, such candidate will have to submit the proof of clearing the respective qualifying examinations with at least minimum percentage required for eligibility at the time of counselling. (For Integrated Programmes/BCA/Certificate Courses)

29. Nothing contained in this Admission Prospectus should be construed to convey sanction or cited as an authority for which University regulations alone are applicable.
30. Any candidate who has been disqualified or debarred by the University or Board or any other Statutory Board shall not be eligible for admission.
31. Canvassing in any form is strictly prohibited. Further, if any candidate, person or official engages himself/herself in any unlawful act or indulges in any kind of unfair means in the Test/Admission, he/she shall be liable to prosecution under relevant laws as per Indian Penal Code.
32. Those applicants who do not furnish complete particulars in the application form will not be considered.
33. If the University/authorities are not satisfied with the character, past behaviour and antecedents of a candidate, they may refuse to admit him/her in the University/ Institute in order to ensure academic standards, discipline and peaceful atmosphere in the University/Institute.

34. All disputes pertaining to admissions in the session 2026-27 are subject to the jurisdiction of Sonapat Court only.
35. All rules and regulations for submission of migration certificate by the candidates who have passed the qualifying examinations from other Universities / Boards will be applicable as per the rules of the concerned university.
36. Reservation shall be applicable as per Haryana Govt. rules.
37. In view of the instruction/guideline received from The Director General, Social Justice & Empowerment Department, Haryana, the Hon'ble Supreme Court of India in its order dated July 08, 2020 observed that Scheduled Castes / Scheduled Tribes candidates are required to obtain 35% passing marks of pass in the aptitude test as against the requirement of 40% for General candidates. The relaxed criteria of 35% pass marks in aptitude test shall apply to the candidates with disabilities also for admission.
38. Any increase / decrease in intake and addition of new courses in the University reported after the publication of the Prospectus shall be included in the list at the time of counselling after approval of the Competent Authority
39. Refund of fee/ dues in the event of cancellation of admission, the Refund Policy of UGC/AICTE/Concerned body received from time to time and as adopted by DCRUST Murthal will be followed.
40. Change in the Schedule/any relevant information shall be displayed on the website; <https://dcrustmadm.samarth.edu.in> and no separate letter shall be sent.
41. If/when required the schedule for 4th/5th and subsequent counselling will be displayed on admission website; <https://dcrustmadm.samarth.edu.in> after third counselling. The Procedure for 4th/5th and subsequent counselling shall be as under: (If required)

If the list of candidates appeared in the Entrance Test/CUET Score (wherever applicable) is exhausted then following procedure will be followed, otherwise candidate from the merit list of Entrance Examination/CUET Score (wherever applicable) will only be considered.
 - a) Already registered candidates can also participate in these counselling and need not to apply again.
 - b) Unregistered candidates are required to fill an application form on samarth admission portal of the university on the day of counselling.
 - c) Time for marking of attendance and submission of applications form is 9:30 a.m. to 11:30 a.m. in the respective departments.
 - d) For these counselling, no applications shall be accepted after 11: 30 a. m.

- e) All admitted candidates shall be charged University Fee as given in prospectus on the day of counselling. Unregistered candidates shall have to pay an additional charge of Rs.1000/- as Registration Fee in addition to fee mentioned in prospectus.
42. Seats shall be filled through following sequence (order of preference) for all counselling as mentioned at Point No. 4 in Chapter 6.
43. As per office order no. DCRUST/279 dated 09.12.2021 in case any student (including OSC/DSC student) get any scholarship/assistantship more than relief amount other than Post Matric Scholarship, such students have to pay full fee applicable to those whose parent's income is more than Rs.2.5 lakhs.

The eligible OSC/DSC students will apply for the Post Matric Scholarship on the related portal as per Govt. Guidelines and the students shall deposit scholarship amount in university, failing which his/her admission will be cancelled. Such students have to submit an undertaking as per Annexure XIX. In case the student does not apply for scholarship in the prescribed time or is found ineligible or he/she does not submit complete documents for award of scholarship he/she will be liable to pay part/full fee along with late fee as per rules.

All other OSC/DSC students are liable to pay full fee including those OSC/DSC students who are admitted to M. Tech. / M. Arch. on the basis of valid GATE SCORE.

For OSC/DSC students interested in fee exemption/waiver it is compulsory to submit income certificate at the time of admission issued on or after 01.04.2026.

44. After completing the work of the admission, the departmental admission committee will submit all the details of admitted students to Chairpersons of respective Department. Chairpersons are required to arrange to make entries of all admitted students on the University Registration Portal.
45. The gross annual income of parents shown in the certificate should be of financial year 2025- 26 and certificate should be issued on or after 01.04.2026.



I am directed to refer to this Department's Instructions No. 22/12/2019-1GS-III dated 25.02.2019, vide which reservation for Economically Weaker Sections (EWS) was provided in direct recruitment to Civil Posts and Services, as well as in admissions to Government and Government Aided Educational Institutions in the State of Haryana. But the family income limit for eligibility under the EWS category was fixed at ₹6.00 lakh per annum.

The matter has further been considered by the Government, and it has now been decided to enhance the family income limit for Economically Weaker Sections (EWS) from ₹6.00 lakh per annum to ₹8.00 lakh per annum, in line with the policy of the Government of India. All other provisions of the said instructions shall remain unchanged.

These instructions may be brought to the notice of all concerned authorities for ensuring strict compliance in letter and spirit.
