ADMISSION NOTIFICATION - 2

Subsequent to Notification No. SECY/UC/2025/2615 dated 08.07.2025 regarding admission at University Law College, Gauhati University, the following is to be noted by all concerned. For any kind of enquiry communication may be sent to : admission_ulcgu@gauhati.ac.in

• **ESSENTIAL POINTS TO BE NOTED BY APPLICANTS :**

1. Applicants are required to apply **online** ONLY.
2. Before applying for the programme, the candidates are advised to go through the admission notification thoroughly.
3. Please check the eligibility conditions before submission of the Online Application Form.
4. Each applicant must scan his/her photograph and signature, ensuring that both the photograph and signature comply with the required specifications as mentioned in the upload section of the online application process.
5. Signature in CAPITAL LETTERS will NOT be accepted.
6. Keep all the necessary details/documents/certificates ready that need to be uploaded in the “documents upload section”, and a successful online payment of the application fee is required to complete the online form submission process.
7. Applicants must have a valid personal email ID and contact number, which should be kept active till the completion of this admission process. Under no circumstances he/she share/mention his/her e-mail ID to any other person. In case an applicant does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID before applying online and must maintain that email account. The email ID and phone number of the students and parents/guardians may be used for further communication.
8. The Application Form for Admission is editable, but once submitted, it will no longer be editable.
9. Candidates seeking admission under OBC/MOBC/SC/ST category must be permanent residents of Assam (PRC must be produced at the time of Admission).
10. Up to date Non-Creamy Layer (NCL) certificate is mandatory for OBC/MOBC category candidates.
11. Up to date EWS certificate is mandatory for EWS category candidates.
12. The University is not responsible for any unwanted technical failure which may disturb the admission process, either at the University's end or from the student's end.

• **PROCEDURE FOR APPLYING ONLINE:**

1. Go to the website: <https://gauhatiadmission.samarth.edu.in/2025/>
2. Click on “**New Registration**” and get yourself registered to fill out the application form. Note down your user ID and password for future reference.
3. After successful completion of the “New Registration” process, click on “**Login**”
4. After successful login, complete your “**Profile**”
5. Click on the appropriate programme.
Programme Level: Bachelor (Undergraduate Programmes)
Programme: Bachelor of Law (5 Year Honours) - for B.A.LL.B./B.A.LL.B. (Hons.) Programme
Bachelor of Law (3 Yr Admn)- for LL.B. Programme
6. Fill up the Form, save and upload all the necessary documents.
7. Submit the form and pay the prescribed fee in the final step.

8. No change to the information filled in by the applicants will be accepted after the final submission of the Application Form.
9. In case the application fee has been debited from your bank account, and if any error is prompted, kindly visit the “Payments” tab to verify your payment.

- **APPLICATION FEE:**

An application fee of Rs **1,000/-** (Rupees One Thousand only) is to be paid online.

- **HOW TO PAY THE APPLICATION FEE ONLINE:**

1. Application fees must be paid through the ONLINE MODE only and other modes of payment will not be accepted. The payment can be made by using Debit Cards (Visa/MasterCard/Maestro), Credit Cards, and Internet Banking/UPI. The fee, once paid, is non-refundable. **It is important to note that an e-receipt of application fee payment may not be generated if an online transaction is unsuccessful.**
2. The application form will be considered finally submitted only after the said fee has been successfully paid by the applicant and an online receipt has been generated confirming payment.
3. After successful completion of the submission of the online application form, applicants need to keep a printout copy of the e-payment receipt and application form for future reference.

All applicants are advised to follow the eligibility criteria before filling up the online admission form. Students are also advised to keep visiting the University website (<https://gauhati.ac.in>) and <https://gauhatiadmission.samarth.edu.in/2025/> from time to time to know about any changes in policy and dates that may occur, if and when required. If a candidate appeared in the University Law College Entrance Test, 2025, without fulfilling the proper eligibility criteria, his/her candidature will be cancelled.

- **SELECTION PROCEDURE:**

1. All candidates **must appear in the Entrance Test** to be admitted to the University Law College, Gauhati University.
2. The selection of eligible candidates for B.A.,LL.B./B.A.,LL.B.(Hons.) and LL.B. programmes admission will be **solely based on the Entrance Test score**. In case of a tie, the candidate shall be selected based on the performance in the last Board/Council/University examinations.
3. Preference for admission will be given to candidates who obtain higher marks in the **Entrance Test**.

- **ADMISSION PROCEDURE:**

1. The schedule and procedure for admission shall be notified on the Gauhati University website (<https://admissions.gauhati.ac.in>) along with the merit list prepared based on the score of the entrance test.
2. The admission and other fees to be paid at the time of admission shall be received through the online payment system of Gauhati University.
3. The selection and admission will be considered provisional. The admission of the candidate shall be cancelled/rejected at any time in case of violation of the required norms, rules, etc. set by the Bar Council of India and Gauhati University from time to time.
4. Seat reservations will be made as per the guidelines established by the Government of Assam and Gauhati University.
5. Merely appearing in the Entrance Test does not confer any right to the candidate for admission to the programme. **If a candidate does not meet the minimum eligibility criteria during the document verification of the admission process, his/her candidature will be cancelled even if selected for admission.**

- **SEAT MATRIX:**

1. Seat reservation policy for the 3-Year LL.B. Programme of the University Law College, Gauhati University, for the Academic Session 2025-26 will be as follows:
 - a) Reservation of 50% of seats for Gauhati University candidates.
 - b) Reservation of 50% of seats for Other University and Gauhati University candidates.
2. Seats in the 5-Year B.A.LL.B./B.A.LL.B.(Hons.) Programme of the University Law College, Gauhati University, remains open to all candidates irrespective of their board/university affiliation.
3. Other reservations of seats shall be as per the provisions of Gauhati University.

• **STATUTORY RESERVATION POLICY:**

- **Scheduled Caste:** 7%
- **Scheduled Tribes (Plains):** 10%
- **Scheduled Tribes (Hill):** 5%
- **OBC & MOBC:** 27% *[As per the letter from the director of Higher Education, Govt. of Assam (Ref. no: DHE/EG/Misc/79/2023/14 dated 20-07-2023), the reservation of seats for OBC/MOBC community is being enhanced from the existing 15% to 27% and this reservation is applicable for the NON-CREAMY LAYER candidates of OBC/MOBC community only. In addition, the reservation of seats for candidates belonging to Ahom, Chutia, Moran, Matak, Koch Rajbongshi and Tea Tribe Community will be within 27% of OBC/MOBC reservation.]*
- **Differently-abled:** 3% of the total seats in each programme for reserved for differently-abled students/persons with benchmark disabilities (with not less than forty per cent of a specified disability). Candidates applying for consideration under this category must submit a Medical Certificate issued by the competent authority. Students applying for reservation under this category must submit a prescribed form for this purpose in the office of the Principal, University Law College, Gauhati University. Candidate must appear in a Medical Board constituted for this purpose if and when called for.
- **Economically Weaker Sections (EWS):** 10% seats are reserved for the Economically Weaker Sections (EWS) in each Academic programme. As per the Government of Assam Office Memorandum, No. ABP.07/2019/3 dated 2nd February, 2019. Candidates applying for consideration under this category must submit a relevant certificate issued by the competent authority.

• **OTHER RESERVATION :**

Reservations of seats under the Other Reservation Categories are as follows:

- **Sons and daughters of Permanent GU Employees:**
- **Sons and daughters of Retired GU Employees**
- **Sons and daughters of Ex-Defense Personnel**
- **NCC:** *Those who have obtained the NCC 'C' certificate. Preference will be given to those who have attended the Republic Day Parade Camp under NCC or a national-level camp under NCC.(for LL.B. admission)*
Those who have obtained the NCC 'B' certificate. Preference will be given to those who have attended the Republic Day Parade Camp under NCC or a national-level camp under NCC.(for B.A.,LL.B./B.A.,LL.B.,(Hons.) admission)
- **NSS:** *Candidate will be selected on the basis of possession of the certificates (obtained in the last 3 years preceding the qualifying examination) placed below in order of weightage:*
 1. *National Level NSS Awardees*
 2. *State Level NSS Awardees*
 3. *Member of the Indian Youth Delegation Team (International Youth Exchange)*
 4. *Republic Day Camp Participants*
 5. *Participation in various National Level NSS Integration Camps and Programmes*
 6. *Participation in various State Level NSS Integration Camps and Programmes/ University Level NSS Programmes*
- **Extra-Curricular & Co-Curricular Activities:** *Eligibility of this quota lies on the basis of the performance of the candidate in the field of Sports/Art/Culture. Proficiency in Extra Curricular & Co-Curricular Activities in the last 3 years preceding the qualifying examination(earlier than three years before the academic session in which admission is sought) will be considered for this purpose. Preference will be given to the candidates in the following order:*
 1. *Those who represented the country in international events*
 2. *Those who won prizes at recognised national-level events*
 3. *Those who won prizes in the inter-university sports/cultural/literary events*
 4. *Those who represented Gauhati University in the inter-university sports/cultural/literary meet, or the state at national events*
 5. *Those who won prizes in the inter-college youth festival, G.U. and inter-college sports Meet, under the G.U. Sports Board*
 6. *Those who won prizes at recognized state-level competitions*
 7. *Students who were awarded fellowships/scholarships by the Central Ministry of Culture, Sports and Youth Welfare for excellence in art, culture and sports, etc.*

- **Fringe Village:** Applicants must be the son/daughter of the residents of the fringe villages, viz. Garigaon, Sadilapur, Katiadalang (North Jalukbari) and Sundarbari. Applicant's fore-fathers must have the residents in these villages at the time of the inception of Gauhati University. Students applying for reservation under this category must submit a form in the prescribed format for this purpose, along with the land ownership documents of the parents and the NRC Data of 1951, to the office of the Principal, University Law College, Gauhati University, Gopinath Bardoloi Nagar, Guwahati-781014, Assam.

* The applicants seeking the above mentioned reservations must indicate the same in the online admission form while filling and submit the printed copy of the online application form and a filled up separate prescribed form along with all required testimonials duly self-attested in the office of the Principal, University Law College, Gauhati University, Gopinath Bardoloi Nagar, Guwahati-781014, Assam in person or by post on or before July 23, 2025 (up to 5 pm). Gauhati University authority will not be responsible for any postal delay.

* Any other seat reservations will be made following the guidelines established by the Government of Assam and Gauhati University.

University Law College Entrance Test - 2025: Gauhati University

❖ **Entrance Examination Pattern:**

- The Entrance Test will consist of 100 multiple-choice questions with four options each, carrying 1(one) mark for each correct answer.
- The duration of the exam will be of 02 hours.
- For each incorrect answer, 0.25 (zero point two five) marks will be deducted.

❖ **Distribution of Marks:**

General Knowledge: (1 x 30)	30 Marks
General English and Comprehension (1 x 30)	30 Marks
General Mathematics (numerical ability) (1 x 10)	10 Marks
Logical Reasoning and Aptitude: (1 x 30)	30 Marks

The General Knowledge component will cover the following fields:

- Legal events and developments
- Current events of Regional, National and International importance
- General Science, including basic Computer knowledge
- History of India
- Geography
- Indian Polity, Sports and Economy
