Privacy Policy, Terms & Conditions, Refund & Cancellation Policy

1. Refund & Cancellation Policy

The following policy shall govern all online admission applications submitted through the Magadh University SAMARTH Admission Portal:

- The application fee paid through the portal is non-refundable and non-transferable under all circumstances.
- Once an application form has been successfully submitted and the payment has been made, no request for cancellation, modification of fee, refund, or chargeback shall be entertained.
- Payment made against an incorrect application, duplicate application, or due to any mistake committed by the applicant shall not be eligible for refund.
- Magadh University shall not be responsible for payments made through cyber cafés, agents, or any third party on behalf of the applicant.
- Applicants are advised to verify all details carefully before final submission and payment.

2. Privacy Policy

Magadh University is committed to protecting the privacy and confidentiality of applicants' personal information collected through the SAMARTH Admission Portal.

Information We Collect

During the admission process, the University may collect information including but not limited to:

- Applicant's name
- Date of Birth
- Parent/Guardian details
- Mobile number
- Email address
- Residential address
- Academic qualifications
- Category details
- Identity proof
- Photograph and signature

3. Use of Information

The information collected shall be used solely for:

- Processing admission applications
- Verification of applicant credentials
- Merit list preparation
- Seat allotment
- Admission-related communication
- Compliance with statutory and regulatory requirements

The University shall not use applicants' personal information for commercial or marketing purposes.

4. Data Security

Reasonable administrative, technical, and physical safeguards are implemented to protect applicant information against unauthorized access, alteration, disclosure, or misuse.

5. Third-Party Services

Payment gateway providers and other authorized service providers may process limited information solely for facilitating online admission services. Such entities shall process data in accordance with applicable laws and contractual obligations.

6. External Links

The University website and admission portal may contain links to external websites. Magadh University is not responsible for the privacy practices, security, or content of such external websites. Users are encouraged to review the privacy policies of those websites before providing any personal information.

7. Terms & Conditions

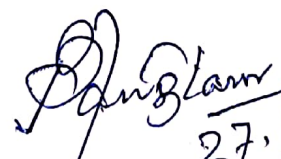
By registering and submitting an application through the Magadh University SAMARTH Admission Portal, the applicant agrees to the following terms and conditions:

1. Submission of an online application does not guarantee admission.
2. Admission shall be strictly subject to:
 - * Eligibility criteria prescribed by the University;
 - * Availability of seats;
 - * Reservation policies of the Government and the University;

* Merit and applicable admission rules.

3. Seat allotment shall be made subject to the availability of the selected programme, subject combination, and sanctioned intake capacity of the respective college.
4. Admission shall be confirmed only after successful verification of the original documents and other credentials by the concerned college.
5. If any information furnished by the applicant is found to be false, misleading, incomplete, or fabricated at any stage, the University reserves the right to reject the application or cancel the admission without prior notice.
6. Applicants are solely responsible for ensuring the accuracy of the information entered in the online application form.
7. The University shall not be responsible for any failure arising from internet connectivity issues, payment gateway interruptions, or technical problems beyond its reasonable control.
8. All disputes relating to admission shall be subject to the jurisdiction of the competent courts at Gaya, Bihar.
9. The decision of Magadh University and the concerned college in all matters relating to admission, eligibility, verification, and seat allotment shall be final and binding.

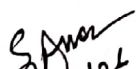
