Participation Eligibility (Who can apply?)

1. Any candidate who have registered by paying Rs. 2500/- for online counselling conducted by MMM University of Technology, Gorakhpur **they don't need to pay Rs. 2500/- as registration fee again.**
2. All other candidates who have not participated in MMMUT counselling process earlier **Such candidates need to pay Rs. 2500/- as registration fee in online mode from registration portal. <https://mmmutadm.samarth.edu.in/>**
3. **MET-2026** will be conducted for those candidates who have not appeared in any national level test like (GATE/GPAT/ CUET(PG)-2026 as applicable).
4. Rank will be prepared after MET-2026 test based on the priority mentioned in the PG admission brochure 2026-27.
5. Seat Acceptance / Confirmation fee. for M.Pharm. (Rs-80000) and for M.Tech and M.Sc. (Rs-20000) must be deposited by the candidate after physical verification in the spot round of counselling. Candidates are required to deposit their remaining university fees (After deducting the confirmation fees before registration/reporting for academic session of 2026-2027 July 25, 2026). All fees must be paid online using the payment gateway services, failing which the provisional admission offered to the candidate will be cancelled.
