- 1. I agree to upload and attend the verification process of original documents to be conducted at TISS Campuses on the dates as and when it is intimated to me through mail / notification. In case of non-submission of any documents/discrepancy found atany stage, my provisional admission will stand automatically cancelled without any claim.
