I declare as under:

1. I agree to upload and attend the verification process of original documents to be conducted at TISS Campuses on the dates as and when it is intimated to me through mail / notification. In case of non-submission of any documents/discrepancy found at any stage, my provisional admission will stand automatically cancelled without any claim.
2. As pre-requirement for provisional admission to the B.A Programme, I shall undergo the Pre-admission Medical Check-Up before joining the Institute for attending the physical classes. In case, I am found / declared medically unfit, my provisional admission will stand automatically cancelled.
3. I have clearly noted that the academic session commences from September 01, 2025 for all campuses. I will have to pay the requisite first semester fees and get original documents verified as per the dates. I will join the campus for attending the classes on the dates, which will be announced by the Institute, otherwise my provisional admission to the said programme shall stand automatically cancelled.
4. I agree to pay all the fees applicable to me for every semester as per the declared fee structure to be eligible to continue on the rolls of the programme.

(Points 5 to 8 applicable only for SC/ST candidates eligible for GoI PMS and not applicable for the self-finance programmes)

5. As I belong to SC/ST category and eligible for the Government of India Post-Matric Scholarship (GOI-PMS), I may be exempted from payment of Tuition and other applicable fees as per GOI PMS.
6. As I belong to SC/ST community and eligible for GOI PMS, I am required to pay only the base fee of ₹ 7,500/- **at the time of admission** to secure the seat, which includes:
(i) Health Care Fund of ₹ 2,000/- towards group medical insurance, (ii) Caution Deposit of ₹ 2500/- (iii) Student Union Fee ₹ 500/- and other charges – 2,500/-.
7. I understand that, if hostel facility is allotted to me, I am required to pay the Hostel Charges of ₹ 18,000/- in two equal installments of ₹ 9,000 each.
8. I understand that if hostel is allotted to me, Dining Hall membership is compulsory and charges will be on actual basis. First advance instalment of ₹ 10,000/- need to be paid to avail the Dining Hall membership and the remaining charges are to be paid on semester basis as per actual bills generated.
